## **Agency Announcements**

Freddie Mac Bulletin <u>2024-4</u> was released on April 3, 2024 and Newrez is aligning with the following topics below.

#### Freddie Mac Bulletin 2024-4

#### **Manufactured Homes**

To evidence the manufactured home is built in compliance with the Federal Manufactured Home Construction and Safety Standards, except for a new manufactured home, either the HUD Certification label(s) or the HUD Data Plate must be present and legible. For a new manufactured home, both the HUD data plate and HUD certification label(s) are required.

The following updates were completed:

- Modified grid for required documents to support both existing or new construction properties to comply with safety standards; and
- Identified appraisal requirements to include photos of the HUD Data Plate and/or HUD Certification label(s)

#### PDR Completion Report Data Set

The updated Uniform Property Dataset (UPD) became mandatory as of April 1, 2024. Additional updated have been completed for the Completion Report Data Set <u>Exhibit 39</u> with the following for July 02, 2024 effective date:

- o Field Names
- Data Point Definitions
- o Implementation Notes and Conditionality

Investor Feature Identifier (IFI): <u>Exhibit 34</u> will be updated to align with the applicable ULDD Data Point Investor Feature Identifier, J44. Effective September 4, 2024, J44 code will apply only to ACE+PDR upgrade to hybrid.

### Newrez Underwriting Guide Updates

#### **Conventional Updates**

#### **Chapter 1G Assets**

Updated 1031 Tax Exchange and removed the following requirements and/or documentation:

- Reverse exchanges are not allowed because the borrower does not hold title to the property at the time of closing.
- No seller provided subordinate financing.
- Verification of the amount of assets being held by the intermediary.

#### **Chapter 1H Liabilities and Debt Ratios**

 New section titled, Rental Housing Payment, added to identify documentation requirements based on either a DU or LPA loan decision, when the borrower does not have a mortgage payment or no housing expense. Reformatted Federal Tax Installment Agreements grid to identify requirements identifying requirements:

- Fannie Mae guidelines in DU column
- Freddie Mac LPA
