## **Chapter 3I Employment and Income**

Net Rental Income updated to clarify:

- Lease Agreements Property Occupied Prior to the New Home:
  - Removed the requirement of only using 75% of rental income. When using the lease agreement, the full rental payment can be used to offset the existing mortgage payment.
- Updated guidelines to reflect the following for Lease Agreements for Subject Multi-Unit Property:
  - o The Veteran/borrower must occupy one unit as their residence.
  - Existing Property The amount of rental income to include in effective income is based on 75% of the amount indicated on the lease or rental agreement unless a greater percentage can be documented (existing property).
  - Proposed Construction: The amount of the rental income to include in effective income is based on 75% of the amount indicated on the appraiser's opinion of the property's fair monthly rental.
